

ORDER:


In view of the circumstances explained and as recommended by the Revenue Divisional Officer, Sangareddy vide references 1st to 3rd read above, permission is hereby accorded under section 61 of A.P. (Telangana Area) Land Revenue Act, 1917 Fasal to appropriate agricultural lands admeasuring acres 26.04 in Sy.No.574 extent acres 12.17 and 578 extent acres 13.27 situated at Fasalwadi village, Sangareddy Mandal into non agricultural purpose i.e. for construction of educational institutions by Sri.M.N. Raju, Managing Trustee, M.N.R. Educational Trust, Kukatapally, Hyderabad on the following terms and conditions.

1. that the lands shall be liable for levy and collection of special assessment under rule 71 of the A.P. (T.A.) Land Revenue Rules or the Non Agricultural Land Assessment Act and Rules whichever is higher.
2. that the permission shall be ceased if the lands are not used for the said purpose with in one year or if the lands used for other than the purpose for permission accorded for non agricultural purpose.
3. that the permission shall not be prejudicial to the provisions of A.P. (TA) Inam Abolition Act, 1954 or Section 38-B of the A.P. (T.A.) Tenancy and Agricultural Land Act, 1950 or the A.P. Assigned Land (Prohibition of Transfers) Act, 1977 or the A.P. Land Reforms (Ceiling on Agricultural Holdings) Act, 1973.
4. that if the lands are not patta, this permission automatically stand cancelled.
