WHEREAS, recognition u/s 15 Act of NCTE, 1993 was granted to the institution namely, M.N.R. Rural P.G. College of Education, M.N.R. Nagar, Fasalwadi Village, Narasapur Road, Sanga Reddy, Medak District-502294, Andhra Pradesh vide order no. F.SRO/NCTE/M.Ed./2007-2008/6762 dt. 17.07.2007 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to M.N.R. Rural P.G. College of Education, M.N.R. Nagar, Fasalwadi Village, Narasapur Road, Sanga Reddy, Medak District-502294, Andhra Pradesh vide order No.F.SRO/NCTE/2010-2011/20604 dated 24.08.2010 from the session 2010-2011.
- 3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 23.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.05.2015 for conducting **M.Ed. programme** of two years duration with an annual intake of **50 students** for **one basic unit** from the academic session 2015-16.
- 4. **AND WHEREAS**, the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 05.02.2019. The institution has not submitted reply to the Show Cause Notice.
- 5. **AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>st</sup> 12<sup>nd</sup> August, 20221 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 28.08.2021. The institution has submitted reply on 18.09.2021 request to close the M.Ed. Programme.
- 6. AND WHEREAS, the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> & 30<sup>th</sup> March, 2022 considered the request for close the M.Ed. Programme matter and decided as under: -

The Committee agreed to close down the institution as requested by the institution vide dated 18.09.2021by withdrawing the recognition granted to MNR College of Education, FasalwadiSangareddy Mandal, Medak District-502294, Telangana for conducting M.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting.

7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to MNR College of Education, Fasalwadi Sangareddy Mandal, Medak District, Telangana-502294 run by MNR Educational Trust, Fasalwadi Sangareddy Mandal, Medak District, Telangana-502294 for

conducting **M.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2022-2023 onwards.

**8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
