ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to MNR College of Education, Fasalwadi, Sangareddy Mandal, Medalk — 502 294, Andhra Pradesh for B.Ed Course of One year duration from the academic session 2000-2001 with an annual intake of 90, subject to fulfilling the following conditions:

- 1. Teacher-Pupil ratio is to be maintained as per para 2.1 of NCTE norms.
- Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course from the academic session 2000-2001.
- The institution shall function with additional teaching staff in addition to Principal, Lecturer for Physical Education and other supporting staff possessing the qualifications as laid down in the NCTE norms and in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.

Faculty members appointed prior to March 2000 and who do not have NET qualification and for whom the requisite relaxation has been obtained from the affiliating University for exemption from NET qualification, such existing staff as were in position possessing the qualification prescribed by NCTE are given a period of two years to acquire the NET qualification.

The staff to be appointed subsequent to the UGC regulations, 2000 regarding minimum qualification for appointment and career advancement of teachers in Universities and Colleges, issued vide No.F.3-1/2000(PS) dated March 2000, relaxation in regard to NET qualification has to be obtained from the UG by the concerned institution through affiliating University.

- The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
- 5. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government.
- Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government till such time NCTE regulations in respect of fee structure come into force.
